



Enclosed is the schedule for the 2020-2021 dance season. Due to the uncertain times we are all navigating, we have made several adjustments to the registration information.

Please read this information carefully, as much of it has changed.

Dance will begin on Monday, September 14th **OR** two weeks from the day we are cleared to open the studio per the Governor's order. The schedule dates and times are subject to change due to the uncertain conditions of the pandemic. Class sizes will be limited. We are offering the following options for registration:

1. Pre-registration: This option will help ensure you get the classes, days, and times you prefer before classes fill-up. To do so, mail in your registration fee, schedule, and liability waiver as soon as possible.
2. Delayed registration: This option will allow you delay registration until a complete plan and start date are determined. However, we cannot guarantee your first choice of classes, days, and times due to limited class sizes.

I have highlighted the days and times of the class options for your child. Please understand that this schedule is tentative and will be based on the registrations received. With that in mind, please know that I will do my best to place your child in classes that are convenient for your schedule.

For returning families, you may use any credit on your account towards registration. However, Pre-registration and Delayed registration will not be accepted until all balances are paid.

We will be holding shoe fitting days. Dates and times will be communicated once we know when we will be able to open for classes. To ensure that your child will have the proper shoes for the first class, please purchase your dance shoes at the time of shoe fitting. We will still have time to order your child's shoes if I do not have them in stock.

In addition to the attached liability waiver, additional information including a COVID-19 waiver and COVID-19 policies and procedures will be sent out once we determine when can open and are provided information on the necessary restrictions.
